**NOTICE OF WITHDRAWAL OF OBJECTION OF
PANOS KORDONOURIS & ASSOCIATES E.E. A/K/A NEW MEDIA CONCEPT
LIMITED PARTNERSHIP AND GOODWIN SOLUTIONS GMBH TO
DEBTOR'S SALE MOTION**

Panos Kordonouris & Associates E.E. a/k/a New Media Concept Limited Partnership (together, the "Company") and Goodwin Solutions GmbH ("Goodwin Solutions"), contract counterparties and/or creditors of AirFastTickets, Inc. (the "Debtor"), by and through their undersigned counsel, hereby withdrawal their Objection [Docket No. 54] to the Debtor's Motion (I) for Authorization to (A) Sell Substantially All of Its Property Free and Clear of All Liens, Claims, Encumbrances, and Other Interests and (B) Assume and Assign Contracts and (II) for Approval of Procedures for Determining Cure Amounts (the "Sale Motion") [Docket No. 27] on the condition that the following language is included in any Sale Order (as defined in the Sale Motion) approved and entered by this Court:

Notwithstanding anything to the contrary in this Order or the PSA, the Property transferred to the Buyer and subject to the Sale shall not include that certain Agreement, dated May 14, 2013 (the "License Agreement") between Panos Kordonouris & Associates E.E. a/k/a New Media Concept Limited Partnership (collectively, "New Media"), as transferred to Goodwin Solutions GmbH ("Goodwin Solutions"), nor shall it include any intellectual property, software and/or source code of New Media and/or Goodwin Solutions, including but not limited to the Booking System (as defined in the License Agreement) and any source code for the Booking System (collectively, the "New Media/Goodwin Solutions Property"). In the event the Debtor and/or Buyer discover that any New Media/Goodwin Solutions Property is on any of the machines or other Property that is transferred as part of the Sale, the Debtor and/or the Buyer shall immediately notify New Media and Goodwin Solutions and provide them with proof by sworn declaration under penalty of perjury that they immediately erased or otherwise destroyed such New Media/Goodwin Solutions Property. Further, the Debtor is not assigning the License Agreement to the Buyer.
