**SUPPLEMENTAL DECLARATION OF ARAM ORDUBEGIAN
REGARDING CUSTOMARY ANNUAL RATE INCREASE**

I, Aram Ordubegian, being duly sworn, state the following under penalty of perjury:

1. I am a partner in the Bankruptcy and Financial Restructuring Group at Arent Fox LLP (“Arent Fox”), a law firm which employs approximately 350 attorneys and maintains an

office for the practice of law at 555 W. Fifth Street, 48th Floor, Los Angeles, CA 90013, as well as offices in Washington, DC; St. Louis, MO; New York, NY; and San Francisco, CA.

2. On December 2, 2015, this Court entered an order [Docket No. 69] (the "**Retention Order**") authorizing the Debtor to retain and employ Arent Fox as its bankruptcy counsel.

3. This declaration is being provided in furtherance of the Retention Order to provide notice of an increase in the rates set forth in the Application.

4. Effective January 1, 2016, the new hourly rates are as follows:

- (a) Partners: \$590 - \$965
- (b) Of Counsel: \$470 - \$940
- (c) Associates: \$330 - \$615
- (d) Paraprofessionals: \$180 - \$335

6. Rate increases for professionals who are expected to perform more than *de minimis* work on behalf of the Debtor in 2016, are as follows:
