**SECOND SUPPLEMENTAL AFFIDAVIT OF RUSSEL C. SILBERGLIED
REGARDING CUSTOMARY ANNUAL RATE INCREASE**

Russel C. Silberglied, being first duly sworn to oath, deposes and says:

1. I am an attorney admitted to practice in the State of Delaware and a director of the firm of Richards, Layton & Finger, P.A. (“RL&F”). RL&F is a law firm with offices at One Rodney Square, 920 North King Street, Wilmington, Delaware 19801.

1. On December 2, 2015, this Court entered an order [Docket No. 70] (the “Retention Order”) authorizing the Debtor to retain and employ RL&F as its bankruptcy counsel.

2. On December 17, 2015, I filed a supplemental affidavit with the Court pursuant to the requirements of the Retention Order, providing ten business days’ notice to the Debtors and

the United States Trustee regarding a customary annual increase in the hourly rates of RL&F professionals. I noted therein that at that time RL&F had not determined the precise amount of increases that would apply to the hourly rates of its professionals. Accordingly, I indicated that RL&F would provide a supplemental affidavit once that determination was made.

3. RL&F's hourly rates now have been reviewed and revised and RL&F has increased the hourly rates of its professionals effective as of January 1, 2016. Those increases, for professionals who are expected to perform more than *de minimis* work on behalf of the Debtor in 2016, are as follows:
