- 6 That no note or other negotiable instrument has been received for the payment of said debt or any part thereof, and that no judgment has been rendered thereon and that said debt is now due payable and unpaid
- 7 That said debt as a claim for state, county and school ad valorem property taxes, has priority and must be paid out of the assets of the bankruptcy estate in advance of distribution to creditors as to the extent provided in Section 506 of the Bankruptcy Act or other applicable statutes
- 8 That said debt as a claim for state, county and school ad valorem property taxes is secured by a statutory lien and that any proceeds from the sale or other disposition of Debtor's property must be used to satisfy said debt

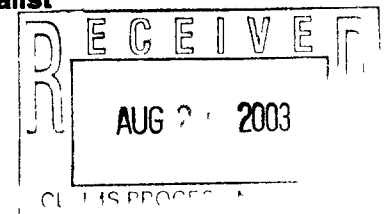
