
Further to my letter of January 16, 2003, I have calculated the specific overcharges that I paid to you during the period of time when you were supplying my local telephone service. These overcharges were as follows:

June 20, 2002 billing	\$58 12
July 20, 2002 billing	40 36
August 20, 2002 billing	63 71
Total	\$162 19

These overcharges are well above the small amount that you claim is owed to you on the final bill. This does not cover the harm done to my business by your action in removing our name from the telephone directory. While your bankruptcy filing precludes any chance of our collecting these amounts from you, it is obvious that the amount you claim is owed by us is not justifiable.
