Enclosed is my proof of claim form which apparently needs to be filed prior to 11/26/03  
If we attached all of the documents, it would be about 6" of files. Rather than trouble you  
with that, our claim comes from a number of items

- 1) The Debtor, its' salespeople and agents, over-charged us for services. After repeated attempts for well over 8 months, we live with lie after lie, new salespersons and representatives after new salespersons and representatives with absolutely no satisfaction.
- 2) When we went to move our office, we notified them verbally as well as in writing. They were supposed to arrange the transfer of service and did not do so. This was primarily because of the ever changing employees and the ineptness of the employees that they had. Consequently, we had no service from 12/23/02 to 12/30/02 at our new location. We were forced to use cell phones and drive back and forth from our old office to pick up faxes and other information. The expense that was incurred is part of this claim. Consequently, one of the Allegiance Vice-President(s) arranged service with Verizon as of 12/30/02. He called from his cell phone and did this on our behalf. The plan was that we would get the service with Verizon and then Allegiance would be able to make all of the changes and we would have our internet service and our phone service with Allegiance in January and at the latest February/2003. This went on and on and on and on and nobody ever addressed our needs. Although they did come to our office and we explained everything and finally the matter went to the legal dept of which, they tried to coerce us into a new two year contract but they did not want to address the first issue of the over-charging and the second issue of the lack of compliance with our service request and the associated jeopardization that we incurred.
