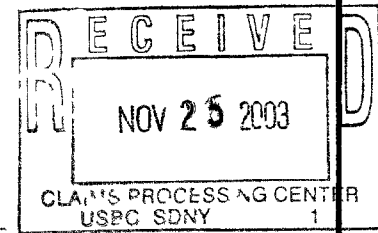

Nextel is filing a Proof of Claim to recover \$718,672.00 as a result of Allegiance fraudulently billing Nextel over the past two years. Allegiance invoiced Nextel for switched access services (Carrier Common Line, Local Switching, and Local Transport), which are charges that Interexchange Carriers ("IXC") are required to pay. Nextel, as a CMRS provider, is not subjected to these charges under current FCC regulations. Since Nextel initiated the dispute, Allegiance has ceased billing Nextel for these services. By discontinuing the billing, Allegiance is admitting that the charges were billed in error. These invalid charges were uncovered during an internal audit and Nextel is requesting a one hundred percent refund for all previously paid invoices.
