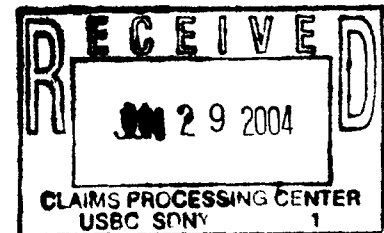
Please be advised that Hosting com owes CUSO Financial Services, LP the sum of \$4,268.25 for account number 000020011032361. Our Internet service with Hosting com was cancelled effective 10/13/02 via telephone. The case number for this cancellation was 103441. Our accounts payable department was not informed of the cancellation, and inadvertently continued to pay for four of the five invoices that Hosting com kept mailing after cancellation. When Michelle Salewala of Hosting com was informed of this, she agreed via e-mail and telephone conversations with Mona Arther, our IT Director, that she would send us a refund check. When a refund check didn't arrive some weeks later, Christine Betts of Hosting com asked us for our billing address so she could mail the refund check. Please see attached e-mail correspondence copies.

After months of waiting for the refund check, I called on 8/22/03 at 1:30 pm (my previous attempts at leaving messages went unanswered). I was finally able to get in contact with a live person, Ralph, who assured me that if I spoke with Monica Henderson, she would assist me with our refund check. Monica never returned my call. I called back the next day and was told by Ralph that the company had filed bankruptcy and that they would not be able to send us a refund at that time. I then requested that they put our company on the list of creditors so that when the bankruptcy claims were to be filed, we would be notified.

We received the bankruptcy notification in the mail on Friday, 6/18/04. Please let me know if there is anything further that I need to do in order to file a claim and receive reimbursement.
