SECOND INTERIM APPLICATION OF LATHAM & WATKINS LLP FOR ALLOWANCE AND PAYMENT OF COMPENSATION AND REIMBURSEMENT OF EXPENSES AS COUNSEL TO THE SPECIAL COMMITTEE OF THE DEBTORS' BOARD OF DIRECTORS

Pursuant to sections 330, 331 and 503(b)(1)(A) of Chapter 11 of Title 11 of the United States Code (the "Bankruptcy Code"), Rule 2016 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"), the Amended Guidelines for Fees and Disbursements for Professionals in Southern District of New York Bankruptcy Cases adopted by the Court on April 19, 1995 (the "Local Guidelines") and the United States Trustee Guidelines for Reviewing Applications for Compensation and Reimbursement of Expenses Filed Under 11 U.S.C. § 330, adopted on January 30, 1996 (the "UST Guidelines" collectively with the Local Guidelines. the "Guidelines"), Latham & Watkins LLP ("Latham"), counsel to the special committee of the board of the directors (the "Special Committee") of the above-captioned debtors and debtors-inpossession (the "Debtors"), respectfully submits this second interim application (the "Application") for allowance of compensation totaling \$77,031.00 and reimbursement for expenses totaling \$5,382.43 for the period from October 1, 2003 through February 29, 2004 (the "Compensation Period").

In support of this Application, Latham respectfully represents as follows:

Background

1. On May 14, 2003 (the "Petition Date"), the Debtors filed voluntary petitions for relief under chapter 11 of the Bankruptcy Code. The Debtors are continuing to possess their property and manage their businesses as authorized under Sections 1107 and 1108 of the Bankruptcy Code.

2. On June 13, 2003, this Court entered an order approving the retention of Latham *nunc pro tunc* to the Petition Date, as counsel to the Special Committee.

3. By Order dated June 13, 2003 (the "Administrative Order"), the Court established a procedure for interim compensation and reimbursement of expenses for all professionals in these cases. In particular, the Administrative Order provides that, absent objection, upon the expiration of twenty days after the service of monthly fee statements, the Debtors are authorized to pay each professional an amount equal to 80 percent of the fees and 100 percent of the expenses requested in their respective monthly fee statements. By this Application, Latham seeks payment of all outstanding monthly fee statements owing (less amounts voluntary writtenoff as described in paragraph 12 below) with respect to Latham's monthly fee statements included in this Application.

4. On November 5, 2003 Latham filed a first fee application covering the period May 14, 2003 through September 31, 2003. On December 17, 2003 this Court entered an order approving the first fee application and allowing fees and expenses in the amounts of \$193,829.50 and \$5,938.50, respectively.

5. The supervisory responsibility for Latham's efforts on behalf of the Special Committee has been borne by Robert J. Rosenberg. Mr. Rosenberg is global co-head of Latham's Insolvency Practice Group and a partner in Latham's New York office. Mr. Rosenberg is a 1967 graduate of Columbia University and a 1970 graduate of Harvard Law School.

Summary of Services Performed During the Current Compensation Period

6. As is reflected in the attached Second Interim Fee and Expense Application Cover Sheet (the "Cover Sheet"), Latham has rendered 128.30 hours of legal services in representation of the Special Committee from October 1, 2003 through February 29, 2004. Based on the nature of the services rendered, the time required to provide such services, the value of such services to the Special Committee, and the cost of comparable services outside a case under the Bankruptcy Code, Latham believes that the compensation for services rendered to the Special Committee, should be not less than \$77,031.00. This total represents 128.30 hours of Latham attorney and other professional time, at a blended average hourly rate of \$600.40. The hourly rate for each attorney and other professional who performed services for the Special Committee is set forth in the Cover Sheet.

7. In accordance with the Local Guidelines, a detailed chronological narrative (the "Billing Detail") of the time spent (divided among two (2) billing categories adopted at the outset of these cases), the dates and descriptions of the services rendered, and the identity of the attorneys and other professionals who provided services on behalf of the Special Committee from October 1, 2003 through February 29, 2004, is attached hereto as Exhibit "A" and incorporated herein by reference. Section III of the Cover Sheet, contains a summary of the services provided by project category.

8. Latham respectfully supplements the attached Billing Detail with the following narrative summary of services rendered by Latham, organized by category.

a. <u>General Case Administration</u>. Latham rendered a total of 124.10 hours and \$75,003.00 in services in the category "General Case Administration." This project contains all of Latham's services rendered in connection with offering general advice to the Special Committee and the individual members thereof on all matters within their province, including attendance at meetings of the Board of Directors and the Special Committee. Areas of advice included all matters where not all directors were independent, including but not limited to the Key Employee Retention Plan and issues related to plan formulation.

b. <u>Investigation</u>. Latham rendered a total of 4.20 hours and \$2,028.00 in services in the category "Investigation." This project contains all of Latham's services rendered in connection with an investigation of allegations made against a senior employee of the debtor which was undertaken by Latham at the request of the Board of Directors and the Special Committee.

Latham's Staffing and Internal Procedures.

10. Latham has made a conscious effort in this case to provide the Special Committee with high quality legal services at the lowest possible cost. Whenever possible, rather than "reinventing the wheel," Latham has drawn upon the considerable expertise of its senior partners to obtain quick answers to difficult questions without the need for expensive and time consuming legal research. Where research has been required, Latham has utilized the low billing rates of junior lawyers, resulting in considerable savings for the Special Committee. Latham respectfully submits that it has been extremely efficient in avoiding duplication of effort and keeping fees and costs at the lowest level possible.

11 Latham believes that the attached Billing Detail reflects the actual, fair and reasonable value of the legal expertise provided to the Special Committee during the Compensation Period.

Disbursements

12. Latham expended a total of \$5,382.43 for reasonable and necessary expenses in connection with its representation of the Special Committee from October 1, 2003 through February 29, 2004.² Latham has voluntary reduced its expenses by \$180.00. In accordance with the Guidelines, Section IV of the Cover Sheet attached hereto and incorporated herein by reference, also contains a summary of the expenses incurred by type.

13. Latham does not build a profit component into its disbursements, and charges the Special Committee only for Latham's actual out-of-pocket expenses. Photocopy charges are billed at \$0.17 per page and outgoing faxes are billed at \$1.25 per page.

Certification

14. As required by the Guidelines, a certification that the facts set forth in this Application are true and correct, and that this Application complies with the Guidelines, is attached hereto as Exhibit "B".

Latham is a Disinterested Person and Holds No Adverse Interest

15. All professional services and expenses for which allowance is requested in this Application were performed by Latham on behalf of the Special Committee and not on behalf of any other entity or person. Latham has neither a claim against, nor an interest in, the Debtors,

² Some charges incurred by Latham during the Compensation Period may not be reflected here due to delays in receiving bills from third party providers. Latham will request any such fees in its next interim fee application.

and no beneficial interest in the Debtors, directly or indirectly, has been acquired or transferred by Latham or for Latham's benefit since the commencement of these cases. Latham represents no interest adverse to the Debtors or the Special Committee with respect to matters upon which it is engaged, and Latham is a "disinterested person" under section 101(14) of the Bankruptcy Code.

16. No agreement or understanding exists between Latham and any other person or entity for the sharing of compensation received or to be received for services rendered in connection with these proceedings, except that fees will be shared with other partners of Latham as permitted by Bankruptcy Rule 2016 and Section 504 of the Bankruptcy Code.

WHEREFORE, Latham respectfully requests that this Court approve: (i) interim compensation in the amount of \$77,031.00 for actual, reasonable and necessary professional services rendered to the Special Committee by Latham during the Compensation Period; and (ii) interim reimbursement by the Debtors of Latham's expenses in the amount of \$5,382.43 for actual, reasonable and necessary expenses incurred on behalf of the Special Committee during the Compensation Period.
