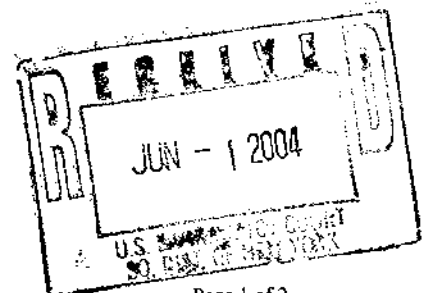

"ASSUMPTION AND ASSIGNMENT OBJECTION"

Alight, Inc. d/b/a We the People Legal Document Service asserts the following Cure Obligation that must be satisfied with respect to the Assumed Contract:

1. Allegiance Telecom, Inc. ("Allegiance") entered into a contract with Alight ("Contract"), whereby Allegiance was to provide phone and internet service for good and valuable consideration to Alight. Allegiance did not perform pursuant to the contract, and therefore is in breach. The Cure Amount with regard to this breach of contract is Fifteen hundred (\$1,500.00) dollars.
2. In response to the above referenced breach of contract, Alight properly terminated the contract with Allegiance. Allegiance in turn billed Alight in the amount of Fifteen hundred (\$1,500.00) dollars for breach of contract. Alight was entitled to terminate the contract, and did so pursuant to the terms of the contract. Allegiance has no claim against Alight for breach of contract.
