ORDER PURSUANT TO SECTION 365(a) OF THE BANKRUPTCY CODE AUTHORIZING THE DEBTORS TO REJECT CERTAIN UNEXPIRED LEASES OF NONRESIDENTIAL REAL PROPERTY

ORDERED that the Motion is granted; and it is further

ORDERED that the Rejected Leases shall be deemed rejected effective as of the date on which the Debtors surrender the respective location to the appropriate lessor as set forth on Exhibit "A" to this Order; and it is further

Unless otherwise defined herein, capitalized terms shall have the meaning ascribed to them in the Motion.

ORDERED that the Debtors do not waive any claims that they may have against

any of the lessors under the Rejected Leases, whether or not such claims are directly related to

the Rejected Leases; and it is further

ORDERED that the Debtors are authorized to take all actions necessary to

effectuate the relief granted pursuant to this Order in accordance with the Motion; and it is

further

ORDERED that this Court shall retain jurisdiction to hear and determine all

matters arising from or related to the implementation of this Order.
