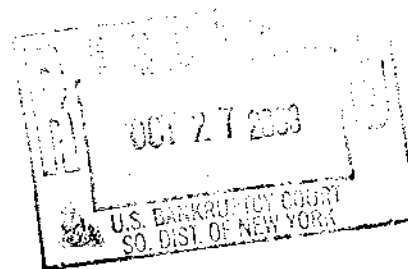
Is it legal for them to attempt to collect a debt (which we deny) for a company that is under your jurisdiction? If not, should you take action against them?
