**NOTICE OF EIGHTH MONTHLY FEE APPLICATION
OF BLANK ROME LLP, DEBTORS' COUNSEL, FOR
COMPENSATION AND REIMBURSEMENT OF EXPENSES FOR
THE PERIOD JANUARY 1, 2010 THROUGH JANUARY 31, 2010**

TO: Parties required to receive notice pursuant to Del. Bankr. L.R. 2002-1.

On March 3, 2010, the Eighth Monthly Fee Application of Blank Rome LLP, Debtors' Counsel, for Compensation and Reimbursement of Expenses for the Period January 1, 2010 through January 31, 2010 ("Fee Application") was filed with the United States Bankruptcy Court for the District of Delaware, 824 N. Market Street, Wilmington, Delaware 19801 (the "Bankruptcy Court"). By the Fee Application, Blank Rome LLP ("Blank Rome") seeks (i) the allowance of interim compensation in the amount of \$33,427.00 and reimbursement of expenses in the amount of \$832.74 incurred in representation of Alset Owners, LLC, *et al.*, (the "Debtors") during the period of January 1, 2010 through January 31, 2010 (the "Application Period"), and (ii) the payment of \$26,741.60 (80% of \$33,427.00) in interim compensation and reimbursement of expenses of the amount of \$832.74.

Any responses or objections to the Fee Application must be filed with the Bankruptcy Court in accordance with the local rules and served upon the undersigned counsel on or before **March 23, 2010 at 4:00 p.m. (EST)**. Copies of the Fee Application are available upon written

request to the undersigned. A hearing on the Fee Application shall be held only in the event timely objections are filed.

Pursuant to the Order Establishing Procedures for Interim Compensation and Reimbursement of Expenses of Professionals, in the absence of any objection or responsive pleading to the Fee Application, Blank Rome is authorized to file a Certificate of No Objection with the Bankruptcy Court, after which the Debtors are authorized to pay to Blank Rome the sum of \$26,741.60 equal to 80% of the fees (\$33,427.00) and the sum of \$832.74 equal to 100% of the expenses requested in the Fee Application. If an objection to certain of the fees and expenses that are the subject of the Fee Application is timely filed and served, the Debtors shall be authorized to pay Blank Rome 80% of the fees and 100% of the expenses not subject to the objection.
