3 the Modified Third Amended Chapter 11 Plan of Reorganization Proposed By HoldCo Advisors,  
4 L.P. (the “Plan”).

5           **PLEASE TAKE FURTHER NOTICE** that the Effective Date of the Plan has occurred and  
6 it is October 4, 2013.

7           **PLEASE TAKE FURTHER NOTICE** that pursuant to Article III.A.1.b of the Plan, all  
8 requests for payment of an Administrative Claim, including claims for professionals’ fees and  
9 expenses, must be filed with the Bankruptcy Court and served on the Reorganized Debtor and the  
10 Office of the United States Trustee no later than sixty (60) days after the Effective Date.

11           **PLEASE TAKE FURTHER NOTICE** that pursuant to Article IV.C. of the Plan, claims  
12 created by the rejection of executory contracts and unexpired leases pursuant to Article IV.A of the  
13 Plan, or the expiration or termination of any executory contract or unexpired lease prior to the  
14 Effective Date, must be filed with the Bankruptcy Court and served on the Reorganized Debtor no  
15 later than thirty (30) days after the Effective Date.
