Pursuant to the attached Supply and Service Agreement, Publix Super Markets, Inc. ("Publix") is entitled to a full credit for all unsold merchandise. At the time Anderson News went out of business, the total credits due to Publix were \$5,071,611.39 and the total payment due to Anderson News was \$3,529,355.80. Payment audit claims of \$2,910.89 are properly credited under the Supply and Service Agreement.

## SUPPLY & SERVICE AGREEMENT

Anderson News, LLC ("Anderson") on its behalf and on behalf of its subsidiaries and Publix Super Markets, Inc. hereby agree that Anderson shall be a distributor of magazines and books to Publix Super Markets, Inc. in Lakeland, Florida. In this supply and service agreement, we will sometimes refer to Anderson as "we", "us", and "our", and will sometimes refer to Publix Super Markets, Inc. as "you" and "your".

1. **Basis of Agreement:** During the term of this agreement, Anderson will be the primary provider of magazines and books (the "Merchandise") to Publix stores (the "Stores") assigned to Anderson by Publix (Exhibit A). From time to time, stores can be added to or removed from the list (Exhibit A) by Publix. If Anderson is unable or chooses not to supply particular merchandise, Publix is free to purchase such Merchandise elsewhere.
2. **Pricing:** During the term, the price to be charged by Anderson for the Merchandise will be determined as described in Exhibit B.
3. **Term:** The term of this agreement will be from October 1, 2007 to July 16, 2009, unless the agreement is terminated before the end of the period as allowed in Paragraph 10 herein.
4. **Credit Terms:**
  - (a). **Payment terms** Payment of the magazine and book invoices, net of return credits, will be issued 28 days postmarked from the date of the Monday after the invoice week ending date. Standard monthly research packages will be reviewed by Publix and a written response to be provided to Anderson within 30 days of receipt of correspondence.
5. **Returns:** All or any part of the Merchandise will be returnable by you for full credit (the "Return Credit"). Credit invoices may be first deducted by Publix twenty eight (28) days from date of the Monday after the invoice week ending date in accordance with terms calculated on delivery invoices.
6. **In-Store Services:** Anderson will, at no additional cost, provide representatives to visit the stores, deliver, stock and assist with displays of Merchandise and remove out dated products from the Stores a minimum of twice per week per store.
7. **Sales Fixtures:** Anderson will, at no additional cost, continue to provide the Stores with mainline fixtures (in quantity and of quality and design as we shall both agree upon) for the display of magazines, books and other Merchandise covered by this Agreement. Mainline fixtures are built for a five-year life expectancy. Anderson and Publix will mutually agree to replace fixtures prior to the five-year life plan when the magazine and book department space is expanded or relocated to a more prominent (high-traffic) position. We will be responsible for repairs and maintenance to mainline fixtures.
8. **Indemnification:** Anderson shall indemnify, defend and hold Publix harmless from and against any and all loss, cost, damage, liability or expense arising out of or related to any accident or other occurrence causing injury to any person or property, which arises in connection with Anderson negligently performing its obligations there under. All property of any description, with the exception of Merchandise stocked on Sales Fixtures, of Anderson at or near the stores covered by this Agreement shall at all times be at the sole risk of Anderson, and Publix shall have no responsibility for any loss or damage to Anderson property from pilferage, robbery, theft, burglary or disappearance, from fire or any other casualty, from the elements or from leaks or defects in or breakdown of any plumbing, wiring,

heating, or air conditioning facilities or other machinery or casualty. This Indemnity is in addition to and does not override any existing indemnities.

9. **Insurance:** Anderson shall carry worker's compensation insurance with respect to its employees. Anderson shall at all times during the term of this Agreement maintain and pay for comprehensive general liability insurance affording protection to Publix and Anderson, naming Publix as an additional insured, for a combined bodily injury and property damage limit or liability of not less than \$3 million for each occurrence. Anderson shall deliver to Publix a certificate of insurance for such policies containing a clause requiring the insurer to give Publix at least ten (10) days written notice of cancellation of such policies.

10. **Termination:** The Term may be terminated by either Anderson or by Publix only "For Cause", as follows:

(1) Publix will be permitted to terminate this Agreement For Cause if:

(a) We fail to service the Stores in substantially the same manner as Publix Stores are being serviced by us as of the date of this letter, and we fail to cure to Publix's satisfaction any problems that you identify to us in writing within thirty (30) days after we receive written notice of the problems, or

(b) We breach any other material provision of this letter agreement and we fail to cure to Publix's satisfaction any breach that you identify to us in writing within thirty (30) days after we receive the notice of the breach, or

(c) We file for bankruptcy protection.

(2) Anderson will be permitted to terminate this Agreement For Cause if:

(a) You fail to make any payment within (10) days of the date payment is due, and you fail to cure the payment default within ten (10) days after we notify you in writing of the payment default, or

(b) You breach any other material provision of this letter agreement and you fail to cure any breach that we identify to you in writing within thirty (30) days after you receive the notice of the breach, or (c) There is a material adverse change in the financial condition of Publix Super Markets, Inc. or

(d) You file for bankruptcy protection.

11. **Confidentiality:** Anderson and Publix agree to maintain the confidentiality of this agreement and the pricing structure, and not to disclose it to anyone other than legal advisors, accountants and consultants who agree to maintain its confidentiality, or under court order or otherwise required by law.

12. **Force Majeure:** Neither Anderson nor Publix will be liable to the other by reason of any failure in performances of this agreement if the failure arises out of acts of God, acts of governmental authority, fires, strikes, riots, war, or any cause beyond the reasonable control of that party. If any such event delays performance, the time allowed for each performance will be extended as mutually agreed.

13. **Waiver**: The waiver by a party of any breach of this Agreement by the other party in a particular instance shall not operate as a waiver of subsequent breaches of the same or different kind. The failure of a party to exercise any rights under this Agreement in a particular instance shall not operate as a waiver of such party's right to exercise the same or different rights in subsequent instances. If either you or we desire to waive any breach of the agreement, the waiver must be in writing and be signed by the party granting the waiver.
14. **Miscellaneous**: All of the terms and conditions of this agreement will be binding on our and your successors and assigns. The agreement will be governed by the laws of the state of Florida. This letter reflects the entire agreement of Anderson and Publix regarding the subject matter of this letter.

This proposal expires thirty (30) days from October 1, 2007 unless this contract is executed by both parties.

Anderson News, L.L.C. and Publix Super Markets, Inc. agree to the terms of this agreement, this 29 day of OCT, 2007.
