¹ Eighty percent (80%) of fees and one hundred percent (100%) of costs incurred through May 31, 2007 are payable pursuant to the Order Granting Motion for Order Establishing Interim Fee Application and Expense Reimbursement Procedure entered herein on February 2, 2005 [Docket No. 204] (the "Knudsen Order"). In August 2006 the Applicant received a payment of \$16,333.00 for 100% of costs incurred January through April 2006, and a payment of \$30,152.50 towards unpaid fees. In January 2007 the Applicant received a payment of \$37,713.00 for 100% of costs incurred May through December 2006, and a payment of \$367,994.79 towards unpaid fees.
