19	The United States Trustee does so for the following reasons:
20	1. There is no prepetition committee as recognized by Title 11 or F.R.B.P. 2007.
21	The use of such a label in a pro hac vice motion presumes too much. A simple disclosure
22	under Rule 2019 is appropriate.
23	
24	2. The court should not grant a motion which is uncertain in its scope. The
25	proposed order simply "grants" the motion and permits the counsel to appear on any
26	
27	matter in the case. That language is overbroad given the description and title of the

3	3. The court should not issue an order that these attorneys may appear for a
4	prepetition committee in this bankruptcy setting where no compliance with Rule 2007 is
5	shown. At best, the group is an unofficial group and the title should so reflect. The
6	group should be re-named to the lead plaintiff or the lawyer's name to avoid any
7	confusion with any official committee that might be appointed.
