ORDER APPOINTING A LEGAL REPRESENTATIVE FOR UNKNOWN TORT CLAIMANTS AND MINORS

By Order of the Court.

THIS MATTER came before the Court for hearing on May 25, 2005 upon the Motion for Order Appointing a Legal Representative for Unknown Tort Claimants and Minors (the "Motion") [Docket No. 327], which was filed by The Catholic Bishop of Spokane a/k/a The Catholic Diocese of Spokane, a Washington corporation sole and the debtor and debtor in possession (the "Diocese" or the "Debtor") in the above captioned Chapter 11 reorganization case;

The Court having considered the Motion, the objections and responses to the Motion, the court records and files, and having considered the arguments of counsel at the hearing, and finding it necessary and advisable to appoint a legal representative for Unknown Tort Claimants as defined herein, in order for such persons to have legal representation in this matter, the Court finds that the Motion should be granted;

NOW, THEREFORE, it is

ORDERED:

1. Gayle E. Bush is appointed as the legal representative for Unknown Tort Claimants who are defined as follows:

a. Those persons who know that they had an incident of sexual contact/touching, sexual abuse, or sexual misconduct by an alleged agent of the Diocese while the claimant was a minor yet, prior to any claims bar date established in this matter, fail to make the connection between such incident and injuries arising therefrom (the "Causal Link Claimants");

b. Those persons who, prior to any claims bar date established in this matter, had not discovered or could not have reasonably discovered that, as a minor, they had an incident of sexual contact/touching, sexual abuse, or sexual misconduct by an alleged agent of the Diocese (the "Category b Claimants"); and

c. Those persons who did not reach the age of eighteen prior to any claims bar date established in this matter who have claims for sexual abuse by an alleged agent of the Diocese (the "Minors");

2. The Unknown Claims Representative is authorized to do all of the following:

a. Subject to applicable rules and statutes concerning intervention, joinder, etc., advocate the legal position of the Unknown Tort Claimants in any proceeding before the Court or in any appellate court, including, but not limited to, proceedings concerning the claims bar date, the filing of proofs of claim by or for Unknown Tort Claimants, and the filing of ballots by or for Unknown Tort Claimants;

b. File pleadings and present evidence, as necessary, on issues affecting the Unknown Tort Claimants; and

c. Take all other actions as are reasonably necessary and appropriate to represent the interests of Unknown Tort Claimants; and it is further

ORDERED that the Unknown Claims Representative shall participate in this case on the same basis as a professional person employed under 11 USC § 327, with compensation to be paid on an hourly basis subject to 11 USC § 327-331 and Bankruptcy Rules 2014-2017; and it is further

ORDERED that the Unknown Claims Representative may, subject to 11 USC §§ 327-331 and FRBP 2014-2017, and on the same basis as a trustee or examiner, employ such experts and other professional persons as may be reasonable and necessary to carry out his duties as the Unknown Claims Representative; and it is further

ORDERED that the appointment of Gayle E. Bush as Unknown Claims Representative is preliminary subject to further order of the Court; and it is further ORDERED that the Debtor shall transmit a copy of this Order to those persons on the Limited Mailing List within two (2) business days of the date this Order is entered and any interested party who objects to the appointment of Gayle E. Bush as the Unknown Claims Representative shall file any such objection with the Court

within ten (10) days of the date this Order is transmitted; and should no objections be timely filed, the appointment of Gayle E. Bush as Unknown Claims Representative shall become final without further notice or hearing; and it is further

ORDERED that nothing contained in this Order shall constitute a finding that (1) any creditor necessarily qualifies as an Unknown Tort Claimant; or (2) any Unknown Tort Claimants actually exist.

THIS ORDER IS ENTERED without prejudice to the Debtor or any party in interest to challenge the validity of any theory (medical, legal or otherwise) associated with the claims held by Causal Link Claimants or Category b Claimants described herein.
