
PRELIMINARY SCHEDULING ORDER

THIS MATTER came on for hearing before the Honorable Patricia C. Williams on September 7, 2005 for the Court's oral ruling regarding the need for an evidentiary hearing concerning the Debtor-in-Possession's Motion for an Order Fixing Bar Date for Filing Proofs of Claim, Approving Claim Forms and Approving the Form of Notice. The court has determined that there will be an evidentiary hearing. NOW, THEREFORE,

IT IS HEREBY ADJUDGED, ORDERED AND DECREED,

1. The debtor is required to file expert declarations in support of its position no later than September 21, 2005. Any party who wishes to submit expert testimony to support debtor's position will do the same by September 21, 2005.
2. Counsel's proposed final scheduling orders shall be filed no later than September 23, 2005.
3. The final scheduling conference will be held on September 26, 2005 at 1:00 P.M. by telephone conference to be initiated by counsel calling 509-353-3183.
4. The evidentiary hearing on the Debtor-in-Possession's Motion for an Order Fixing Bar Date for Filing Proofs of Claim, Approving Claim Forms and Approving the Form of Notice is scheduled for November 17 and 18, 2005 beginning at 9:00 A.M. in open court. At that hearing witnesses may appear by video if advance arrangements are made.
