NOTICE OF FILING OF SECOND SUPPLEMENTAL SCHEDULE OF EXECUTORY CONTRACTS TO BE ASSUMED IN CONNECTION WITH THE DEBTORS' JOINT PLAN OF REORGANIZATION UNDER CHAPTER 11 OF THE BANKRUPTCY CODE

PLEASE TAKE NOTICE that on September 20, 2013, the Debtors filed the *Debtors' Joint Plan of Reorganization Under Chapter 11 of the Bankruptcy Code* [Docket No. 379] (as amended, supplemented or modified from time to time, the "Plan").²

PLEASE TAKE FURTHER NOTICE that on November 27, 2013, in accordance with and pursuant to the Plan, the Debtors filed the plan supplement (the "Plan Supplement") containing, among other things, the schedule of the Executory Contracts and unexpired leases to

be assumed and the applicable proposed Cure Amounts, which was attached to the Plan Supplement as Exhibit E (as supplemented and amended, the “Assumption Schedule”).

PLEASE TAKE FURTHER NOTICE that subject to the terms of the Plan, the Debtors, with the consent of the Sponsor, reserved the right to supplement and amend the Plan Supplement, and each of the documents contained therein and attached thereto.

PLEASE TAKE FURTHER NOTICE that on December 6, 2013, the Debtors filed a supplemental schedule of Executory Contracts to be assumed and the applicable proposed cure amounts (the “First Supplemental Assumption Schedule”), which supplements the Assumption Schedule.

PLEASE TAKE FURTHER NOTICE that on December 20, 2013, the Debtors filed a second supplemental schedule of Executory Contracts to be assumed and the applicable proposed cure amounts (the “Second Supplemental Assumption Schedule”), which further amends the Assumption Schedule (a) to include the correct agreements between Atari, Inc. and Oracle America, Inc. and (b) corrects the proposed cure amounts for the Executory Contracts between the applicable Debtors and Google, Inc. that were previously listed on the Assumption Schedule. A copy of the Second Supplemental Assumption Schedule is attached hereto as **Exhibit 1**.
