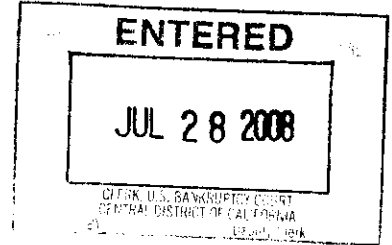
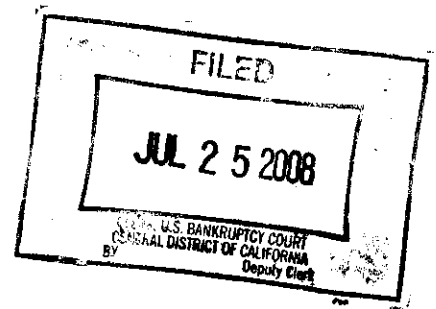

25 On July 25, 2008, the Court held a hearing on the "Debtor's Motion For Order
26 Authorizing Joint Administration Of Related Cases And Of Related Debtors' Income And

1 Expenses Pursuant To 11 U.S.C. § 105 And Bankruptcy Rule 1015(B)” (the “Motion”)¹ filed by
2 James C. Gianulias, the above-captioned debtor (“Mr. Gianulias”).

3 William N. Lobel of Irell & Manella LLP appeared at hearing on behalf of the Debtor.
4 Paul J Couchot of Winthrop Couchot Professional Corporation appeared on behalf of Cameo
5 Homes. All other appearances were as noted in the record of the hearing.

6 After considering the arguments made in the Motion, the Memorandum of Points and
7 Authorities, the Declaration of John McFadden in support of the Motion, the pleadings and
8 documents on file in this case, the oppositions thereto, and the arguments made by counsel at the
9 hearing, this Court hereby finds that: (a) notice of the Motions was adequate and appropriate under
10 the circumstances; (b) any objection to the Motion has been either overruled, withdrawn or
11 resolved; and (c) other good cause exists for the relief requested in the Motion,

12 **IT IS HEREBY ORDERED** that:


- 13 1. The Motion is granted, *EXCEPT AS TO CONSOLIDATION OF INCOME AND EXPENSES OF RELATED DEBTORS.* *no*
- 14 2. The chapter 11 cases of Gianulias and Cameo shall be jointly administered;
- 15 3. All pleadings related to the Debtors’ chapter 11 cases shall bear a joint caption in
16 substantially the form attached hereto as Exhibit “1”;
- 17 4. The Clerk of the Bankruptcy Court shall maintain a joint pleadings docket, under
18 James C. Gianulias, Case No. 8:08-bk-13150-RK, for all pleadings filed in the Debtors’ cases; and
- 19 5. *DEBTORS, GIANULIAS AND CAMEO HOMES, ARE AUTHORIZED*
20 *TO DISBURSE UP TO \$100,000 FOR PAYMENT OF THEIR*
21 *POST-PETITION OPERATING EXPENSES TO THE G COMPANIES*
22 *ON AN INTERIM BASIS.* *up*




