





- 12. The Cliffs at Mountain Park Golf & Country Club, LLC, AKA The Cliffs at Mountain Park Golf and Country Club, LLC. failed to pay Plaintiff for its provision of labor and materials on the Project.
- 13. Heretofore, Plaintiff filed with the Register of Deeds for Greenville County, South Carolina a Notice and Certificate of Mechanics' Lien (the "Notice") within 90 days of the last day Plaintiff provided labor and materials to the Project. The Notice is filed in Book 64 beginning at page 140. A copy of said Notice is attached hereto as Exhibit A and incorporated herein by this reference.
- 14. The Notice was provided to the Owner within 90 days of the last day Plaintiff provided labor and materials to the Project.
- 15. Simultaneously with the filing of this action, Plaintiff has filed with the Clerk of Court for Greenville County its Notice of Lis Pendens. The Notice of Lis Pendens was filed, and this action was commenced within six months of the last day Plaintiff provided labor and/or materials to the Project.
- 19. Plaintiff claims a Mechanics' Lien on the real property and improvements being more fully described in Exhibit A attached to this Complaint and hereby requests that this Mechanics' Lien be foreclosed for the satisfaction of the debt, pursuant to S.C. Code § 29-5-1 0, et. seq., as amended, together with attorney fees, interest and costs to the Plaintiff.

FOR A SECOND CAUSE OF ACTION (Breach of Contract)

- 20. The allegations of the preceding paragraphs are incorporated herein by reference.
- 21. Plaintiff fully performed its contract with The Cliffs at Mountain Park Golf & Country Club, LLC, AKA The Cliffs at Mountain Park Golf and Country Club, LLC.
- 22. The Cliffs at Mountain Park Golf & Country Club, LLC, AKA The Cliffs at Mountain Park Golf and Country Club, LLC. breached its contract with Plaintiff in all, but not limited to, the following particulars:



- (a) by failing to pay Plaintiff for labor, materials and services furnished to the Project.
- 23. As a direct and proximate result of the breach of the contract, Plaintiff has been damaged and is entitled to a judgment against The Cliffs at Mountain Park Golf & Country Club, LLC, AKA The Cliffs at Mountain Park Golf and Country Club, LLC. in a minimum amount of \$31,013.00 plus reasonable attorney fees, prejudgment interest, and costs associated with this action, totaling \$39,000.00.

FOR A THIRD CAUSE OF ACTION (Quantum Meruit)

- 24. The allegations of the preceding paragraphs fully incorporated herein by reference.
- 25. Plaintiff provided labor, materials and services to the project for use by The Cliffs at Mountain Park Golf & Country Club, LLC, AKA The Cliffs at Mountain Park Golf and Country Club, LLC., Owner.
- 26. The Cliffs at Mountain Park Golf & Country Club, LLC, AKA The Cliffs at Mountain Park Golf and Country Club, LLC. Owner accepted, used and benefited from Plaintiff's provision of labor, materials and services.
- 27. Despite demand made, Plaintiff remains unpaid for the provision of its labor, materials and services resulting in the unjust enrichment of The Cliffs at Mountain Park Golf & Country Club, LLC, AKA The Cliffs at Mountain Park Golf and Country Club, LLC., Owner and Plaintiff is entitled to recover the fair value of same, which amounts to a minimum of \$31,013.00 plus interest and costs.

FOR A FOURTH CAUSE OF ACTION (Violation of SC Code 27-1 -1 5)

- 28. The allegations of the preceding paragraphs are fully incorporated herein by reference.
- 29. Pursuant to SC Code Section 27-1-15, Plaintiff, through letter of its counsel, made due and just demand upon The Cliffs at Mountain Park Golf & Country Club, LLC, AKA The Cliffs at Mountain Park Golf and Country Club, LLC, via certified mail, on November 18, 2011 said letter sent to The Cliffs at Mountain Park Golf & Country Club, LLC, AKA the Cliffs at Mountain Park Golf and Country Club, LLC, on or about November 23, 2011. A copy of the letter is attached hereto and incorporated herein as Exhibit B.
- 31. Despite such demand The Cliffs at Mountain Park Golf & Country Club, LLC, AKA The Cliffs at Mountain Park Golf and Country Club, LLC., failed to pay Plaintiff.
- 32. Therefore, Plaintiff is entitled to interest at the judgment rate on the \$31,013.00 since the date of the demand, i.e. November 18, 2011 plus cost and attorney fees.



WHEREFORE, Plaintiff prays for the following relief:

- 1. That it be awarded \$31,013.00 under its Mechanics' Lien, together with reasonable attorney fees, interest and the costs of this action, totaling 39,000.00.;
- 2. That the rights and priorities of others claiming an interest in the property be ascertained and determined;
- 3. That the subject property, described above, be sold, subject to any senior liens having priority over the lien of the Plaintiff, and free and clear of any junior lien, and the proceeds of the sale after deducting all lawful charges and expenses, be applied to the discharge of the amount due to the Plaintiff, including reasonable attorney fees, interest and costs;
- 4. That judgment be entered against The Cliffs at Mountain Park Golf & Country Club, LLC, AKA The Cliffs at Mountain Park Golf and Country Club, LLC., for breach of contract, Quantum Merit and violation of SC Code 27-1-15 and that the Plaintiff be awarded the \$31,013.00 due, together with reasonable attorney fees, interest and costs and actual, totaling 39,000.00.;
- 5. That judgment be entered against Owner under the Quantum Merit cause of action in the amount of \$31,013.00.
- 6. For such other and further relief that the Court deems just, equitable and proper.
