**ORDER APPROVING DEBTOR'S OBJECTION
TO THE ALLOWANCE OF CLAIM NOS. 374 AND 375 FILED BY THOMAS AND
KRISTIN CRAIN**

Upon the Objection [Docket Entry # 903] (the "Objection") of CCHG Liquidation Co., the above-captioned substantively consolidated debtor (the "Debtor"), requesting the entry of an order disallowing claims filed by Thomas and Kristin Crain in the chapter 11 cases of The Cliffs Club & Hospitality Group, Inc. and its affiliated debtors;¹ the Court having jurisdiction to

consider the Objection and the relief requested therein; due notice of the Objection and opportunity for a hearing thereon having been given to all parties entitled thereto, as listed in the certificate of service attached to the Objection and filed with the Court; it appearing that no other or further notice need be provided; the deadline to respond to the Objection having passed, and no objections having been filed or asserted; the Court having determined that the relief sought in the Objection is in the best interests of the Debtor's substantively consolidated bankruptcy estate, its creditors, and all parties in interest; and after due deliberation and sufficient cause appearing therefor, it is hereby ORDERED as follows:

1. The Objection is GRANTED.

2. Claim number 374 filed by Thomas and Kristin Crain in the debtors' bankruptcy cases is disallowed because the record before the Court reflects that none of the debtors is liable to the claimant with respect to the asserted claim, the claimant having waived such claim pursuant to a settlement agreement.

3. Claim number 375 filed by Thomas and Kristin Crain in the debtors' bankruptcy cases is disallowed because the record before the Court reflects that none of the debtors is liable to the claimant with respect to the asserted claim, the claimant having waived such claim pursuant to a settlement agreement.


