ORDER AND NOTICE OF HEARING ON THE  
DISCLOSURE STATEMENT TO ACCOMPANY THE JOINT CHAPTER 11  
PLAN FILED BY THE DEBTORS AND THE PLAN SPONSOR

To the debtors, their creditors, and other parties in interest:

On May 22, 2012, The Cliffs Club & Hospitality Group, Inc. and its affiliated debtors in the above-captioned Chapter 11 cases, as debtors and debtors-in-possession (collectively, the “Debtors”),<sup>2</sup> filed the Disclosure Statement to Accompany the Joint Chapter 11 Plan filed by the Debtors and the Plan Sponsor (the “Disclosure Statement”) pursuant to section 1125(b) of Title 11, United States Code, 11 U.S.C. §§ 101 *et seq.* and Rule 3017 of the Federal Rules of Bankruptcy Procedure, in connection with the Joint Chapter 11 Plan filed by the Debtors and the Plan Sponsor (the “Plan”), now, therefore:

**IT IS ORDERED** and **NOTICE IS HEREBY GIVEN**, that:

1. The hearing to consider the approval of the Disclosure Statement shall be held on **July 2, 2012 at 10:00 a.m.** at: **J. Bratton Davis United States**

2. The last day for filing and serving in accordance with Fed. R. Bankr. P. 3017(a) written objections to the Disclosure Statement shall be **June 28, 2012**.

3. With the consent of the counsel for the Official Committee of Unsecured Creditors, the Debtors and the Plan Sponsor are authorized to communicate with current and former members of the Debtors' clubs to facilitate their understanding and consideration of the New ClubCo Membership Plan with respect to their election, as set forth on the ballot for Class 7 Club Member Claims, of whether to become members of New ClubCo following confirmation of the Plan, it being understood that such informational activity will not involve a solicitation of a vote in favor of or against the Plan unless and until a Disclosure Statement is approved by this Court.

4. Within three (3) business days after entry of this Order, the Disclosure Statement and Plan shall be served in accordance with the Order Establishing Certain Notice, Case Management and Administrative Procedures [Docket Entry No. 121] and distributed to the Debtors, the Official Committee of Unsecured Creditors, the Securities and Exchange Commission, the United States Trustee and any party in interest who requests in writing a copy of the Disclosure Statement or Plan in accordance with Fed. R. Bankr. P. 3017(a). This Order and notice of hearing shall be served in accordance with the Order Establishing Certain Notice, Case Management and Administrative Procedures [Docket Entry No. 121] and distributed to all creditors and indenture trustees in accordance with Fed. R. Bankr. P. 2002(b).
