**DEBTORS' OBJECTION TO THE ALLOWANCE OF CLAIM NOS. 1304 AND 1305
FILED BY GUILLERMO RODRIGUEZ AND JEFFREY CRAWFORD**

COME NOW The Cliffs Club & Hospitality Group, Inc. and its affiliated debtors in the above-captioned Chapter 11 cases, as debtors and debtors-in-possession (the "Debtors") and hereby object to the allowance of claims filed by Guillermo Rodriguez and Jeffrey Crawford in

the above-styled cases (the “Objection”). In support of this Objection, the Debtors show the Court as follows:

I. Relief Requested

1. By this Objection, the Debtors respectfully request the entry of an order, pursuant to Section 502 of the Bankruptcy Code and Federal Rule of Bankruptcy Procedure 3007, disallowing the claims filed by Guillermo Rodriguez and Jeffrey Crawford in the above-styled cases.

II. Jurisdiction

2. This Court has jurisdiction over this Objection under 28 U.S.C. § 1334. Venue of this proceeding is proper pursuant to 28 U.S.C. §§ 1408 and 1409. This is a core proceeding within the meaning of 28 U.S.C. § 157(b)(2).

III. Background

3. On February 28, 2012 (the “Petition Date”), the Debtors filed voluntary petitions for relief under Chapter 11 of the Bankruptcy Code.

4. On March 12, 2012, the United States Trustee appointed the Official Committee of Unsecured Creditors (the “Committee”) in these Chapter 11 cases pursuant to that certain Fourth Amended Appointment of Committee of Unsecured Creditors [Docket Entry No. 141]. No trustee or examiner has been appointed in these Chapter 11 cases.

5. The Debtors are authorized to operate their businesses as debtors-in-possession pursuant to Sections 1107 and 1108 of the Bankruptcy Code.

6. On April 10, 2012, the Court established May 31, 2012 (the “Claims Bar Date”) as the deadline for non-governmental-entity creditors wishing to assert pre-petition claims against the Debtors to file their proofs of claim with BMC Group, Inc., the Debtors’ claims and noticing agent (the “Claims Agent”) [Docket Entry No. 278].

7. On June 1, 2012, Guillermo Rodriguez and Jeffrey Crawford filed an unsecured non-priority claim against the Debtors in the amount of \$591,305.00. The claim was assigned as claim number 1304 by the Claims Agent. On June 1, 2012, Guillermo Rodriguez and Jeffrey Crawford filed another unsecured non-priority claim against the Debtors in the amount of \$384,954.00. The claim was assigned as claim number 1305 by the Claims Agent (together, claim number 1304 and claim number 1305 are hereinafter referred to as the “Rodriguez / Crawford Claims”).

8. The Debtors have the authority to pursue claims litigation with respect to claims filed in these bankruptcy cases. The Debtors have reviewed proofs of claim filed in these cases. This Objection is the result of the Debtors’ review.

IV. Basis for Relief Requested

9. The documents and materials submitted with the Rodriguez / Crawford Claims reflect that none of the Debtors is liable to the claimant with respect to the asserted claims, and that, at best, a third party non-Debtor entity may be liable to the claimant. The books and records of the Debtors do not reflect an obligation owing to the claimants. Accordingly, the claims are unenforceable against the Debtors, and should be disallowed. Unless the Rodriguez / Crawford Claims are disallowed, Guillermo Rodriguez and Jeffrey Crawford will receive a larger recovery than that to which they are entitled.

10. Moreover the Claims Agent received the Rodriguez / Crawford Claims after the Claims Bar Date. Accordingly, the Rodriguez / Crawford Claims were untimely filed, and should be disallowed. Unless the Rodriguez / Crawford Claims are disallowed, Guillermo Rodriguez and Jeffrey Crawford will receive a larger recovery than that to which they are entitled.

V. Reservation of Rights

11. The Debtors reserve the right to supplement this Objection and to subsequently object to the Rodriguez / Crawford Claims on any other appropriate ground, whether or not stated herein. In addition, the Debtors reserve the right to object to any and all other claims filed in the Debtors' cases, and any other claims asserted by Guillermo Rodriguez and Jeffrey Crawford.

VI. Notice

12. Notice of this Objection has been provided to Guillermo Rodriguez and Jeffrey Crawford and each other party entitled to notice, as listed in the certificate of service filed in connection herewith. In light of the nature of the relief requested, the Debtors submit that no other or further notice is necessary.

WHEREFORE, the Debtors respectfully request that this Court:

1. enter the proposed order attached hereto as Exhibit "A";
2. disallow the Rodriguez / Crawford Claims; and
3. grant the Debtors such other and further relief as is just and proper.
