

NOTICE OF AMENDMENT TO SCHEDULE OF ASSUMED CONTRACTS

PLEASE TAKE NOTICE OF THE FOLLOWING:

On July 27, 2012, The Cliffs Club & Hospitality Group, Inc. and its affiliated debtors in the above-captioned chapter 11 cases, as debtors and debtors-in-possession (collectively, the “Debtors”) filed that certain Statement of Changes Made by Amendment to the First Amended and Restated Joint Chapter 11 Plan filed by the Debtors and the Plan Sponsor dated June 30, 2012, pursuant to which the Debtors made certain amendments to the First Amended and Restated Joint Chapter 11 Plan Filed by the Debtors and the Plan Sponsor dated June 30, 2012 (the “Plan”), specifically including certain amendments to the Schedule of Assumed Contracts attached as Exhibit 1 to the Plan.
