Any party that has filed and served an objection to the motions, and that fails to appear at the time and place above noticed to prosecute that objection, may not have the objection considered. If the party filing the document referred to above has not served the document as required by the Federal Rules of Bankruptcy Procedure and the Local Rules of this Court, the filing party is hereby notified that, at the hearing above referenced, the Court may give notice of the possible imposition of sanctions against the filing party pursuant to Rule 9011 of the Federal Rules of Bankruptcy Procedure for failure to effect service.
