**CONSENT ORDER GRANTING DEBTORS' OBJECTION TO THE ALLOWANCE OF
CLAIM NO. 1109 FILED BY MORGAN CONCRETE CO.

Upon the Objection (Docket Entry # 548) (the "Objection") of The Cliffs at Mountain Park Golf & Country Club, LLC, one of the jointly administered debtors (the "Debtors"), requesting the entry of an order disallowing as duplicative Claim No. 1109 filed by Morgan Concrete Co.; it appearing that Morgan Concrete Co. consents to the relief set forth herein, as

evidenced by the signature of its representative below; the Court having jurisdiction to consider the Objection and the relief requested therein; due notice of the Objection and opportunity for a hearing having been given to all parties entitled thereto and all parties who have appeared in the case and requested notice, as listed in the certificate of service attached to Objection and filed with the Court; it appearing that no other or further notice need be provided; no objections having been filed or asserted; the Court having determined that the relief sought in the Objection is in the best interests of the bankruptcy estates, their creditors, and all parties in interest; and after due deliberation and sufficient cause appearing therefor, it is hereby ORDERED as follows:

1. The Objection is GRANTED.
2. Claim number 1109 filed by Morgan Concrete Co. as a secured Mechanic's Lien claim in one of the above-styled cases is disallowed as duplicative of Claim No. 995.
3. Only Claim No. 995 in the amount of \$20,041.80 filed as a secured claim of a mechanic's lien claimant will be considered as Morgan Concrete Co.'s claim in these Chapter 11 cases.
4. The Court shall retain jurisdiction to hear and determine all matters arising from the implementation of this Order.
