debtors and debtors-in-possession (the “Debtors”), requesting the entry of an order disallowing claims filed by Enigma Corporation in the above-styled cases, the Court having jurisdiction to consider the Objection and the relief requested therein; due notice of the Objection and opportunity for a hearing thereon having been given to all parties entitled thereto, as listed in the certificates of service filed in connection with the Objection and notice of hearing thereon; it appearing that no other or further notice need be provided; the deadline to respond to the Objection having passed, and no objections having been filed or asserted; the Court having determined that the relief sought in the Objection is in the best interests of the Debtors' now substantively consolidated bankruptcy estate, its creditors, and all parties in interest; and after due deliberation and sufficient cause appearing therefor, it is hereby ORDERED as follows:

1. The Objection is GRANTED.
2. Claim number 1047 filed by Enigma Corporation in the above-styled cases is disallowed because the record before the Court reflects that none of the Debtors is liable to the claimant with respect to the asserted claim.
3. Claim number 1076 filed by Enigma Corporation in the above-styled cases is disallowed because the record before the Court reflects that none of the Debtors is liable to the claimant with respect to the asserted claim.
4. This Court shall retain jurisdiction to hear and determine all matters arising from the implementation of this Order.
