1 Upon review and consideration of the *Debtors' Notice Of Motion And Motion*
2 *Pursuant To Bankruptcy Code Sections 105(a) And 363 For Entry Of An Order Authorizing The*
3 *Employment Of Executive Sounding Board Associates Inc. To Provide Crisis Management Services*
4 *And To Provide Robert D. Katz To Serve As Chief Restructuring Officer From The Petition Date*
5 [Docket No. 80] (the "Motion"),¹ filed by Colorep, Inc. and Transprint USA, Inc. (collectively, the
6 "Debtors"), the Declaration of Robert D. Katz filed in support of the Motion, and the Declaration of
7 Danielle A.. Pham regarding non-receipt of opposition to the Motion, the Court hereby finds that
8 notice was appropriate under the circumstances, and good cause exists to grant the Motion as set
9 forth herein. Accordingly,

10 **IT IS HEREBY ORDERED, ADJUDGED, AND DECREED THAT:**

- 11 1. The Motion is granted in its entirety.
- 12 2. The agreement ("ESBA Agreement") with Executive Sounding Board
13 Associates, Inc. ("ESBA") to provide crisis management services and also to provide Robert D. Katz
14 to serve as the Debtors' Chief Restructuring Officer ("CRO"), as well as any required additional
15 temporary staff (the "Temporary Staff"), including, but not limited to Mr. Paul Newton, is approved,
16 *nunc pro tunc* to July 10, 2013 (the "Petition Date"). The appointment of Mr. Katz as the Debtors'
17 CRO is approved, *nunc pro tunc* to the Petition Date.
- 18 3. ESBA's Proposed Postpetition Retainer in the amount of \$85,000 is approved
19 and shall be funded from the first funds available under the DIP Financing Facility.
- 20 4. ESBA is not required to submit fee applications pursuant to sections 330 or
21 331 of the Bankruptcy Code. ESBA is required to provide to the Office of the United States Trustee
22 ("US Trustee") and counsel for any official statutory committees that may be appointed in these
23 cases, reports of staffing, compensation earned and expenses incurred on a monthly basis, with
24 respect to the prior month. Such reports shall include the names of individuals assigned and the
25 functions filled by such individuals, summarize the services provided, identify the compensation for
26 the CRO and any Temporary Staff, and itemize the expenses incurred. ESBA will provide notice of

1 such filing to the US Trustee and counsel for any official statutory committees, providing a ten (10)
2 day time period from the date of issuance for objections to be filed. Such staffing and compensation
3 for fees and expenses shall be subject to review by the Court only in the event that an objection is
4 filed within such ten (10) day time period.
