1 I, PAM KIRACOFÉ, declare as follows:

2 1. I am over 18 years of age and if called upon I would and could competently
3 testify to the matters set forth herein from my own personal knowledge. I am currently an employee
4 of Transprint USA, Inc. ("Transprint"), and have been an employee of Transprint since 1998. My
5 official title is General Ledger Accountant. My daily duties involve supervising and organizing
6 accounts receivable, vendor invoicing, bank statements, and accounts payable for Transprint.

7 2. I submit this Declaration in support of the *Debtors' Omnibus Response to*
8 *Objections Filed by Virginia Electric and Power Company d/b/a Dominion Virginia Power [Docket*
9 *No. 72] and Columbia Gas of Virginia, Inc. [Docket No. 88] to Amount and Scope of Adequate*
10 *Assurance that Certain Utilities are Entitled to Under Bankruptcy Code Section 366.*

11 3. On or around July 10, 2013, I was asked by the then-interim CEO of
12 Transprint, Mark Fox, to assist in obtaining email addresses for certain creditors and utility providers
13 for Transprint and Colorep, Inc. (together, the "Debtors"). In order to do so, I initially looked at the
14 Debtors' business records, and pulled any email addresses of creditors and utility providers that I
15 believe were either used by the Debtors in the past, or were provided to us by some other method
16 from the creditors or utility providers. If this step did not uncover an email address for a creditor or
17 utility provider, I personally contacted by telephone such creditors and utility providers so as to
18 obtain a proper email address to serve certain of the Debtors' pleadings. As part of this task, I
19 uncovered or received, for Virginia Electric and Power Company d/b/a Dominion Virginia Power
20 ("Dominion"), the following email address for Barbara Smith, Barbara.ann.smith@dom.com. I also
21 uncovered or received, for Columbia Gas of Virginia, Inc. ("Columbia"), the following email
22 addresses for Keith Martin and Sandra Crew, respectively, kmartin@nisource.com and
23 slcrew2@nisource.com. I do not specifically recall whether I received the email addresses for
24 Columbia and Dominion from my initial search of the Debtors' records or by contacting these
25 entities directly, but I had no reason to suspect that the email addresses used were not good email
26 addresses to provide Columbia and Dominion with notice of the Debtors' bankruptcies and
27 pleadings.
