**Bar Date for the Bankruptcy Court:** On May 17, 2013, the United States Bankruptcy Court for the District of Delaware opened a case pursuant to Chapter 11 of the United States Bankruptcy Code. The Court has appointed a Chapter 11 Trustee to administer the estate of the debtor, The New York Times Company, Inc. ("NYT") and to conduct the liquidation of the assets of the debtor. The Court has also appointed a Chapter 11 Debtor's Representative to represent the debtor in the Court.

**Who Must File a Proof of Claim:** Any person who has a claim against the debtor, or any person who has a claim against the debtor's estate, including holders of claims allowable under section 541(c)(2) of the Bankruptcy Code, MUST FILE A PROOF OF CLAIM on or before the General Bar Date, unless the claimant is otherwise notified by the Chapter 11 Trustee. The Chapter 11 Trustee will not accept a claim for payment or distribution of assets unless the claimant has filed a proof of claim on or before the General Bar Date, unless the claimant is otherwise notified by the Chapter 11 Trustee.
