for Retained Professionals (Docket No. 168) (the “Interim Compensation Order”), entered April 11, 2013, any objections to the Application were to be filed and served no later than August 5, 2013, at 4:00 p.m. (Eastern).

Pursuant to the Interim Compensation Order, the Debtors are authorized and directed to pay Gavin/Solmonese LLC, \$5,448.85 (the sum of \$5,446.00, which represents eighty percent (80%) of the fees for the period of June 1, 2013 through June 30, 2013, and \$2.85, which represents 100% of the expenses requested in the Application for the same period) upon the filing of this certification and without the need of a court order.
