**NOTICE OF LIQUIDATING TRUSTEE'S FIRST OMNIBUS

PLEASE TAKE NOTICE that on September 18, 2013, the Trustee (the "Liquidating Trustee") of the Conexant Liquidating Trust filed the attached *Liquidating Trustee's First Omnibus (Non-Substantive) Objection to Certain Duplicative Claims* (the "First Trust Omnibus Objection") with the United States Bankruptcy Court for the District of Delaware, 824 Market Street, 3rd Floor, Wilmington, Delaware 19801 (the "Bankruptcy Court"), objecting to your claim(s) in these bankruptcy cases. **Substantive rights may be affected. Your claim(s) may be disallowed as a result of the First Trust Omnibus Objection. Therefore, you should read the First Trust Omnibus Objection carefully.** If you do not want the Bankruptcy Court to reduce, reclassify, and/or disallow your claim(s), then you or your attorney must (i) file a written response (a "Response") to the First Trust Omnibus Objection with the Bankruptcy Court, as set forth in the First Trust Omnibus Objection, and (ii) serve the Response so that it is actually received by the undersigned counsel to the Liquidating Trustee on or before **October 16, 2013 at 4:00 p.m. (Eastern Daylight Time)**.

PLEASE TAKE FURTHER NOTICE if no Response to the First Trust Omnibus Objection is timely filed, served and received in accordance with the above procedures, an order may be entered granting the relief requested in the First Trust Omnibus Objection without further notice or hearing. If a Response to the First Trust Omnibus Objection is timely filed, served and received in accordance with the above procedures, a hearing on the First Trust Omnibus Objection and the Response will be held before the Honorable Mary F. Walrath at the United States Bankruptcy Court for the District of Delaware, 824 North Market Street, 5th Floor, Wilmington, Delaware 19801, on **October 24, 2013 at 2:00 p.m. (Eastern Daylight Time)** (the "Hearing"). Only a Response made in writing and timely filed and received will be considered by the Bankruptcy Court at the Hearing.

IF YOU FAIL TO RESPOND IN ACCORDANCE WITH THIS NOTICE, THE BANKRUPTCY COURT MAY GRANT THE RELIEF REQUESTED IN THE FIRST TRUST OMNIBUS OBJECTION WITHOUT FURTHER NOTICE OR HEARING.
