**NOTICE OF EXPUNGEMENT OF AMENDED AND SUPERSEDED
CLAIMS AND CORRESPONDING ADJUSTMENT OF CLAIMS REGISTER**

TO: HOLDERS OF CLAIMS LISTED AS CREDITORS ON EXHIBIT A HERETO

PLEASE TAKE NOTICE that, as reflected on Exhibit A hereto, the Trustee (the “Liquidating Trustee”) of the Conexant Liquidating Trust has determined that your previously filed general unsecured claim or claims (the “Superseded Claims”) against the estates of the above-captioned debtors (collectively, the “Debtors”) have been amended and superseded by your later filed general unsecured claims (the “Surviving Claims”) against the estates of the Debtors, and therefore your Superseded Claims have been expunged.

PLEASE TAKE FURTHER NOTICE that, Article VII.D. of the *Second Modified Joint Plan of Reorganization of Conexant Systems, Inc. and Its Debtors Affiliates Pursuant to Chapter 11 of the Bankruptcy Code* (the “Plan”) (Docket No. 206) provides that the Reorganized Debtors or any party administering the claims may expunge any claim that has been amended and superseded without having to file an objection and without any further notice to or action, order or approval of the Bankruptcy Court, and may adjust the Debtors’ official register of claims (the “Claims Register”) to reflect the expungement.

PLEASE TAKE FURTHER NOTICE that pursuant to Articles VI.D(1)(c) and VII.B of the Plan, paragraphs 113 and 121 of the order (Docket No. 287) confirming the Plan, and section 3.6 of the Liquidating Trust Agreement (Docket No. 241, Exh. K), the Liquidating Trustee is the party administering the general unsecured claims.

PLEASE TAKE FURTHER NOTICE that, as reflected on Exhibit A hereto, the Liquidating Trustee has determined to expunge your Superseded Claim(s) identified on Exhibit A hereto under the column "Expunged Claim" and adjust the Claims Register to reflect that those claims have been expunged.

PLEASE TAKE FURTHER NOTICE that you shall retain your Surviving Claim(s) identified on Exhibit A hereto under the column "Surviving Claim," subject to the Liquidating Trustee's rights, without limitation, reserved immediately below.

PLEASE TAKE FURTHER NOTICE that the Trustee expressly reserves, without limitation, the right to amend, modify or supplement this Notice, file additional notices of adjusted and expunged claims, adjust and expunge claims, and file objections on a non-substantive and substantive basis to the Superseded Claims (if and as necessary), the Surviving Claims, and to any other claims asserted against the Debtors' estates.
