

Commencement of Chapter 11 Cases. On February 28, 2013, (the “*Petition Date*”), Conexant Systems, Inc. and certain of its affiliates, as debtors and debtors in possession (collectively, the “*Debtors*”) filed voluntary petitions for relief under chapter 11 of title 11 of the United States Code (the “*Bankruptcy Code*”), in the United States Bankruptcy Court for the District of Delaware (the “*Bankruptcy Court*”).

Debtors’ Adequate Assurance. On the Petition Date, the Debtors filed the *Debtors’ Motion for Entry of Interim and Final Orders (I) Determining Adequate Assurance of Payment for Future Utility Services, (II) Prohibiting Utility Providers from Altering, Refusing or Discontinuing Utility Service and (III) Establishing Adequate Assurance Procedures*, [Docket No. 10] (the “*Motion*”). On March 1, 2013, the Bankruptcy Court entered the *Interim Order (I) Determining Adequate Assurance of Payment for Future Utility Services, (II) Prohibiting Utility Providers from Altering, Refusing or Discontinuing Utility Service and (III) Establishing Adequate Assurance Procedures and Setting a Final Hearing*, [Docket No. 42] (the “*Interim Order*”). A copy of the Interim Order is enclosed herewith.
