


**INSTRUCTIONS FOR PROOF OF CLAIM FORM**

**Items to be completed in Proof of Claim form**

**Court, Name of Debtor, and Case Number:**

If the authorized agent is a servicer, identify the corporate servicer as the company. Criminal penalties apply for making a false statement on a proof of claim.

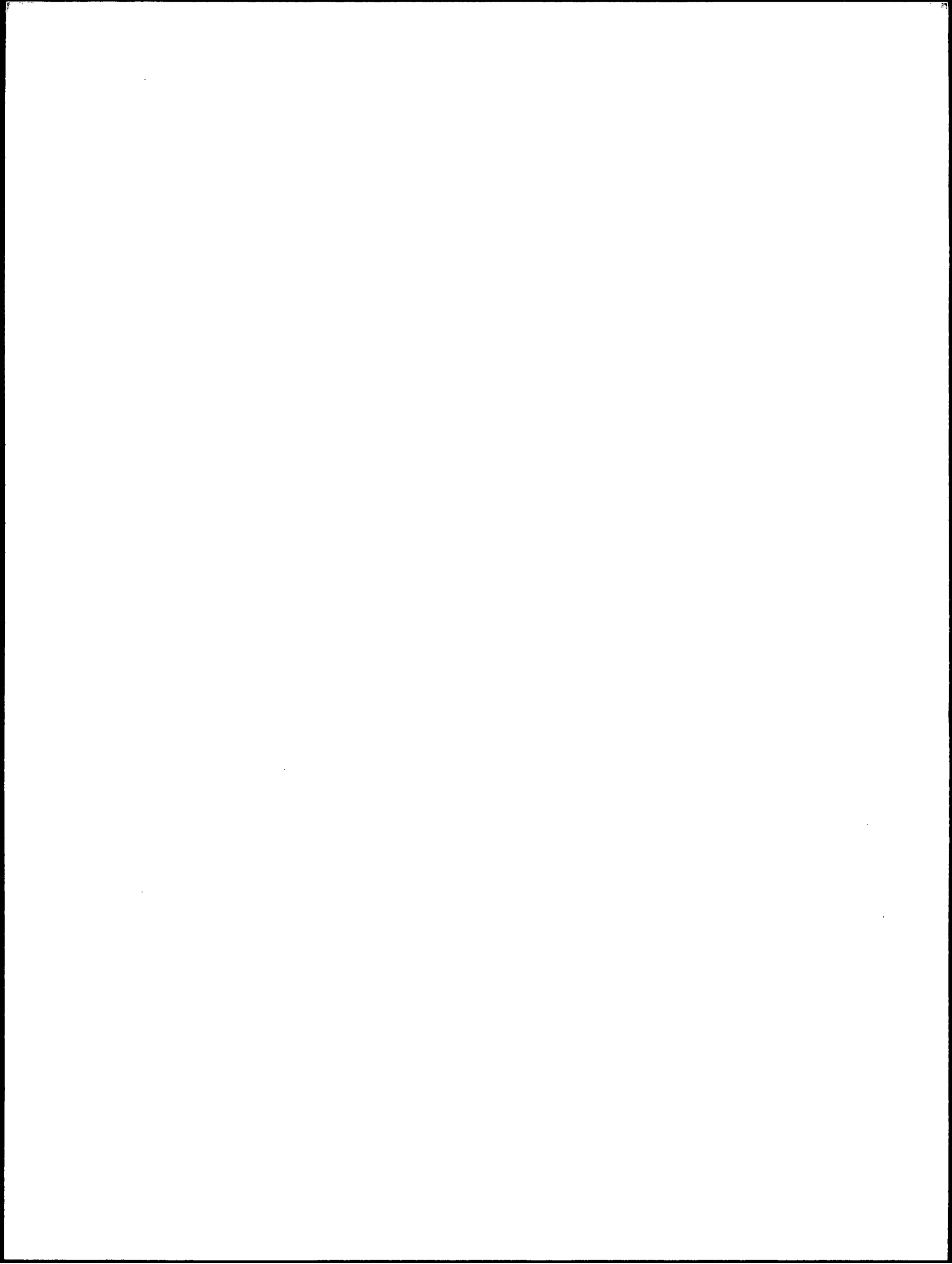

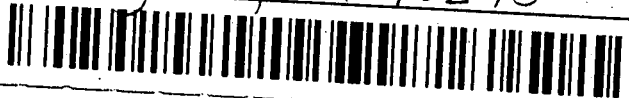

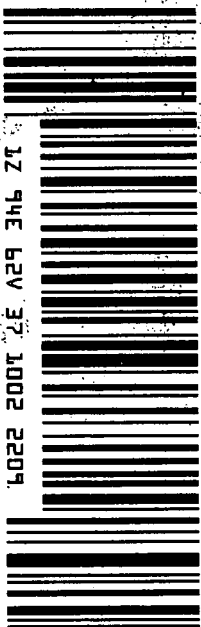
