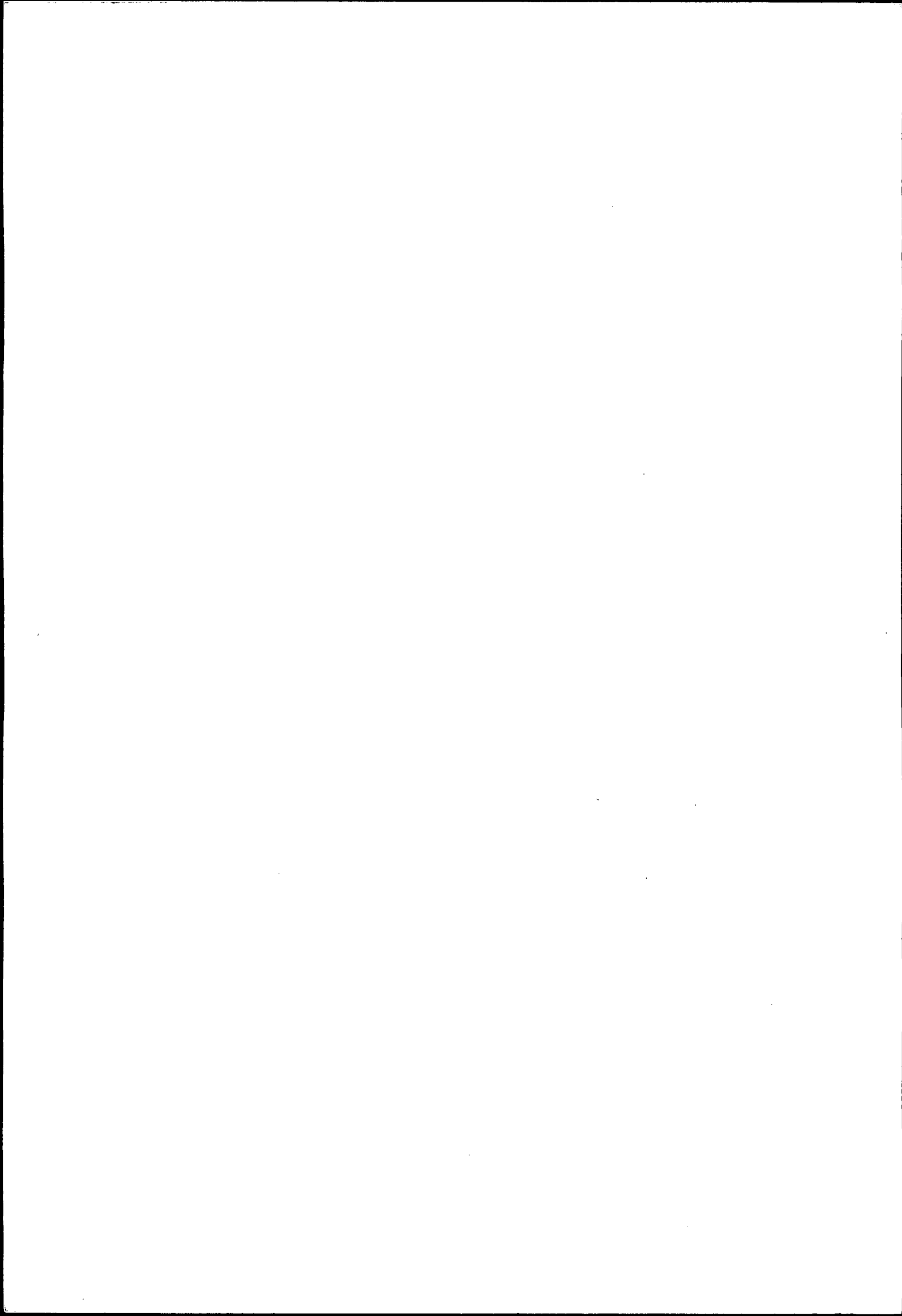

VI. Background

Conexant Systems, Inc. (hereinafter referred to as "Debtor") is a vendor to Teco Image Systems Co., Ltd. (hereinafter referred to as "TIS"). TIS uses Debtor's products as a component in its own products. TIS is a vendor to Konica Minolta.

VII. Basis of Claim-Indemnity

Konica Minolta has notified TIS that they are being sued for products that TIS provided and will be seeking indemnity from TIS pursuant to their Sales and Purchase Agreement. The suit was filed by Telecomm Innovations, LLC against Konica Minolta on October 4, 2012 for patent infringement claims. The case was filed in the District of Delaware (case number 1:2012-cv-01270-SLR). The products in question were provided by Debtor to TIS and by TIS to Konica Minolta. Debtor has been notified of Konica Minolta's claim for indemnity against TIS. This case is believed to have been dismissed by stipulation. TIS will seek reimbursement or indemnification from Debtor should Konica Minolta exercise their indemnity rights against TIS.

VIII. Amount Claimed

The amount claimed is unknown at this point. The amount stated in the Proof of Claim is only an estimate. The litigation is believed to have been dismissed by stipulation and the damages, attorney fees, and other costs, if any, are unknown.

IX. No Admission of Liability

The filing of this Proof of Claim is not an admission of liability for the underlying lawsuit.

X. Reservation of Rights

TIS hereby asserts all claims it has or may have against Debtor, at law, in equity or otherwise, including specifically the amounts detailed above, plus costs of collection, including attorneys' fees to the extent allowed by law.

TIS has not yet completed its investigation of actions by the Debtor, and thus, expressly reserves the right to amend this claim to add additional bases for liability as well as additional costs which it is entitled under § 502 or otherwise.

TIS asserts all rights to indemnity, contribution, subrogation, and insurance coverage that it may have, including without limitation any rights under Rule 3005. TIS reserves all rights to setoff and recoupment.

TIS reserves the right to amend its claim at any time to include amounts incurred and not paid, and/or assert claims or amounts which may arise post-petition to the extent allowable by law, including but not limited to attorneys' fees, interest and other charges and fees associated thereto, as applicable. Nothing in this claim is an admission that any amounts which are administrative claims should be treated as pre-petition claims, and TIS reserves all rights to amend this claim.

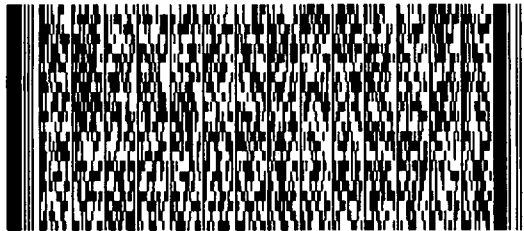

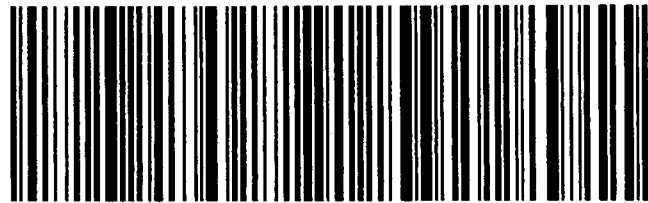
