# CFC ESTATE'S MOTION FOR SUMMARY JUDGMENT DISALLOWING CLAIM NO. 49676-0282

Pursuant to Fed.R.Bankr.P. 7056 and Fed.R.Civ.P. 56, the CFC Estate respectfully moves this Court for summary judgment that Calvary Mobile Homes, Inc. ("<u>Calvary</u>") waived any claim that it may have had for breach of the Amended Finance Agreement and/or for unfair or deceptive trade practices under N.C.G.S. § 75-1.1.<sup>2</sup>
