**AGREED ORDER RESOLVING BIO-MEDICAL APPLICATIONS OF MISSISSIPPI,
INC. OBJECTION**

Before this Court is the objection filed by Bio-Medical Applications of Mississippi, Inc. d/b/a Clarksdale MS Inpatient Services (“**Bio-Medical**”) [Docket No. 1042] (the “**Bio-Medical Objection**”) with respect to the *Notice of [I] Debtors’ Intent to Assume and Assign Certain Executory Contracts, Unexpired Leases of Personal Property, and Unexpired Leases of Nonresidential Real Property and (II) Cure Amounts Related to the Foregoing* [Docket No. 970]. Based upon the signatures of counsel below and the representations of counsel for Debtors, CHS/Community Health Systems, Inc. (“**Purchaser**”), and Bio-Medical that the parties have entered into a stipulation resolving the Bio-Medical Objection (the “**Stipulation**”), and the Court finding good cause therefor;
