**AGREED ORDER RESOLVING GE HFS, LLC OBJECTION**

Before this Court is the objection filed by GE HFS, LLC (“**GE HFS**”) [Docket No. 1005] (the “**GE HFS Objection**”) with respect to the *Notice of: (I) Debtors’ Intent to Assume and Assign Certain Executory Contracts, Unexpired Leases of Personal Property, and Unexpired Leases of Nonresidential Real Property; and (II) Cure Amounts Related to the Foregoing* [Docket No. 970]. Based upon the signatures of counsel below and the representations of counsel for CHS/Community Health Systems, Inc. (“**Purchaser**”) and GE HFS that the parties have entered into a stipulation resolving the GE HFS Objection (the “**Stipulation**”), and the Court finding good cause therefor;

**IT IS ORDERED** that the GE HFS Objection is resolved as set forth in the Stipulation among GE HFS and Purchaser.
