**AGREED ORDER FURTHER EXTENDING RESPONSE DEADLINE FOR STEVEN D
SASS LLC, IN ITS CAPACITY AS LIQUIDATING TRUSTEE AND DEBTOR
REPRESENTATIVE TO THE AMENDED MOTION FOR ALLOWANCE AND
PAYMENT OF ADMINISTRATIVE EXPENSE PRIORITY CLAIMS FILED BY
THE USF GROUP, INC.**

This matter is before the Court on the *Amended Motion for Allowance and Payment of*

Administrative Expense Priority Claims filed by The USF Group, Inc. (the “USF Administrative Expense Request”) [Docket No. 1233].

The deadline to respond to the USF Administrative Expense Request was originally established as September 3, 2019 (the “USF Administrative Expense Response Deadline”).

Pursuant to the *Agreed Order Extending Response Deadline for Steven D Sass LLC, in its Capacity as Liquidating Trustee and Debtor Representative to the Amended Motion for Allowance and Payment of Administrative Expense Priority Claims Filed by the USF Group, Inc.* [Docket No. 1239], the USF Administrative Expense Response Deadline was extended, as to Steven D Sass LLC, in its Capacity as Liquidating Trustee and Debtor Representative (the “Trustee”), to September 30, 2019.

Pursuant to the *Agreed Order Extending Response Deadline for Steven D Sass LLC, in its Capacity as Liquidating Trustee and Debtor Representative to the Amended Motion for Allowance and Payment of Administrative Expense Priority Claims Filed by the USF Group, Inc.* [Docket No. 1253], the USF Administrative Expense Response Deadline was extended, as to the Trustee, to October 30, 2019.

On the one hand the Trustee and on the other hand The USF Group, Inc., each by and through their undersigned counsel, have agreed to the further extension of the USF Administrative Expense Response Deadline from October 30, 2019, to November 13, 2019, therefore,

IT IS HEREBY ORDERED THAT:

1. For the Trustee, the USF Administrative Expense Response Deadline is extended from October 30, 2019, up to and including November 13, 2019.

2. This Order only extends the USF Administrative Expense Response Deadline for the Trustee and does not extend the USF Administrative Expense Response Deadline for any other party.
