**ORDER GRANTING THE CURAE HEALTH LIQUIDATING TRUST'S  
THIRD OMNIBUS OBJECTION TO PROOFS OF CLAIM  
(DUPLICATIVE CLAIMS)**

Before the Court is the *Curae Health Liquidating Trust's Third Omnibus Objection to Proofs of Claim (Duplicative Claims)* (the "Objection"), and the Court having concluded that (i)

it has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334, (ii) this matter is a core proceeding pursuant to 28 U.S.C. § 157(b), (iii) venue is proper pursuant to 28 U.S.C. §§ 1408 and 1409, (iv) good and sufficient notice of the Objection has been given and a reasonable opportunity to object to, or be heard has been afforded to all interested persons and entities, (v) any objections to the relief requested in the Objection have been withdrawn or overruled, and (vi) the legal and factual bases set forth in the Objection establish just cause for the relief granted herein,

IT IS THEREFORE ORDERED THAT:

1. The Claims identified as “Disallowed Claims” on Schedule 1 to this Order shall be disallowed and expunged in their entirety. The Claims identified as “Surviving Claims” on Schedule 1 are unaffected by this Order.

2. The Liquidating Trust’s objection to each Claim addressed in the Objection constitutes a separate contested matter as contemplated by Bankruptcy Rule 9014. This Order shall be deemed a separate Order with respect to each Claim. Any stay of this Order pending appeal by any of the claimants subject to this Order shall only apply to the contested matter which involves such claimant and shall not act to stay the applicability and/or finality of this Order with respect to the other contested matters covered hereby.

3. The Liquidating Trust shall retain and shall have the right to object in the future to any of the proofs of claim listed on Schedule 1 attached to this Order on any additional grounds, and to seek to amend, modify, and/or supplement this Order as may be necessary.

4. The Debtors’ noticing agent, BMC Group, Inc. is hereby directed to serve this Order on the Claimants identified in Schedule 1 to this Order.

5. For Alliance Health Care Services, Inc., as to Proof of Claim No. 65-00171 only, the response deadline to the Objection is extended up to and including April 5, 2021, and if a timely response to the Objection is filed, a hearing shall be held on April 7, 2021, at 11:00 a.m. and will be conducted via an AT&T telephonic hearing, which can be accessed by calling 1-888-363-4749 and using the Access Code 7250422#.

6. For Gifted Nurses LLC, as to Proof of Claim Nos. 78-00015 and 65-00159 only, the response deadline to the Objection is extended up to and including April 5, 2021, and if a timely response to the Objection is filed, a hearing shall be held on April 7, 2021, at 11:00 a.m. and will be conducted via an AT&T telephonic hearing, which can be accessed by calling 1-888-363-4749 and using the Access Code 7250422#.

7. This Court shall retain jurisdiction over the Debtors and the claimants whose Claims are subject to the Objection with respect to any matters related to or arising from the Objection or the implementation of this Order.
