**AGREED ORDER EXTENDING RESPONSE DEADLINE FOR OFFICIAL COMMITTEE OF UNSECURED CREDITORS OF CURAE HEALTH, INC., ET AL. TO DEBTORS' MOTION FOR ENTRY OF AN ORDER (I) AUTHORIZING AND APPROVING BIDDING PROCEDURES FOR THE SALE OF PANOLA MEDICAL CENTER, (II) AUTHORIZING THE SALE OF PANOLA MEDICAL CENTER FREE AND CLEAR OF ALL LIENS, CLAIMS, ENCUMBRANCES AND OTHER INTERESTS, (III) APPROVING STALKING HORSE PURCHASER, BREAK-UP FEE, AND OVERBID PROTECTIONS, (IV) ESTABLISHING CERTAIN PROCEDURES FOR THE ASSUMPTION AND ASSIGNMENT OF EXECUTORY CONTRACTS AND UNEXPIRED LEASES, (V) SCHEDULING AN AUCTION, (VI) SCHEDULING A**

**HEARING AND OBJECTION DEADLINES WITH RESPECT TO THE SALE OF  
PANOLA MEDICAL CENTER, (VII) APPROVING THE FORM AND MANNER OF  
NOTICE THEREOF, AND (VIII) GRANTING RELATED RELIEF**

This matter is before the Court on the *Debtors' Motion for Entry of an Order (I) Authorizing and Approving Bidding Procedures for the Sale of Panola Medical Center, (II) Authorizing the Sale of Panola Medical Center Free and Clear of All Liens, Claims, Encumbrances and Other Interests, (III) Approving Stalking Horse Purchaser, Break-Up Fee, and Overbid Protections, (VI) Establishing Certain Procedures for the Assumption and Assignment of Executory Contracts and Unexpired Leases, (V) Scheduling an Auction, (VI) Scheduling a Hearing and Objection Deadlines with Respect to the Sale of Panola Medical Center, (VII) Approving Form and Manner of Notice thereof, and (VIII) Granting Related Relief* (the "Batesville Sale Motion") [Docket No. 401].

The deadline to object to the Batesville Sale Motion was set for November 20, 2018 (the "Batesville Sale Objection Deadline"). The Debtors and the Official Committee of Unsecured Creditors of Curae Health, Inc., *et al.* (the "Committee") agreed to the extension of the Batesville Objection Deadline from November 20, 2018, to November 26, 2018, at 11:00 a.m. Central Time. *See* [Docket No. 470].

The Debtors and the Committee, each by and through their undersigned counsel, have agreed to the further extension of the Batesville Sale Objection Deadline to the hearing on the Batesville Sale Motion, which is scheduled for November 27, 2018, at 2:00 p.m. Central Time (the "Batesville Hearing"), therefore,

**IT IS HEREBY ORDERED THAT:**

1. For the Committee, the Batesville Sale Objection Deadline is extended from November 26, 2018, at 11:00 a.m. Central Time to the Batesville Sale Hearing, where the Committee is entitled to orally raise any objections to the Batesville Sale Motion.

2. This Order only extends the Batesville Sale Objection Deadline for the Committee and does not extend the Batesville Sale Objection Deadline for any other party.
