**JOINT MOTION TO CONTINUE HEARING ON FIRST OMNIBUS MOTION FOR ENTRY OF AN ORDER (I) AUTHORIZING THE DEBTORS TO REJECT CERTAIN EXECUTORY CONTRACTS AND UNEXPIRED LEASES AND (II) GRANTING CERTAIN RELATED RELIEF (DOC. 620) AND OBJECTION OF DRAYER PHYSICAL THERAPY INSTITUTE, LLC (DOC. 676)**

This matter is set for a hearing on February 5, 2019, on the Debtor’s *First Omnibus Motion for Entry of an Order (i) Authorizing the Debtors to Reject Certain Executory Contracts and Unexpired Leases and (ii) Granting Certain Related Relief* (Doc. 620, the “Motion”) and the *Objection of Drayer Physical Therapy Institute, LLC* thereto (Doc. 676, the “Objection”).
