EXPEDITED AGREED ORDER (A) ADJOURNING THE EVIDENTIARY HEARING ON DEBTORS' MOTION FOR ENTRY OF AN ORDER (I) AUTHORIZING DEBTORS TO PAY THE DIP OBLIGATIONS, (II) AUTHORIZING THE USE OF CASH COLLATERAL, (III) GRANTING ADEQUATE PROTECTION, (IV) MODIFYING THE AUTOMATIC STAY, AND (V) GRANTING RELATED RELIEF; AND (B) ADJOURNING THE BRIEFING DEADLINES WITH RESPECT THERETO

IT IS ORDERED, ADJUDGED, AND DECREED THAT:

1. The Motion for Adjournment is granted as set forth herein.
2. The Evidentiary Hearing is adjourned to March 26, 2019, commencing at 11:00 a.m., Courtroom 2, 701 Broadway, Nashville, TN.
