

SCHEDULING ORDER RE MOTION FOR COURT APPROVAL OF
STIPULATION AND ORDER RESOLVING CURE CLAIM OF UNIVERSAL CARE

The court having held a hearing on July 26, 2005, on the Reorganized Debtors' Motion for Court Approval of Stipulation and Order Resolving Cure Claim of Universal Care, Inc. (Docket Entry ("DE") No. 2510), this order sets forth a briefing schedule for the parties:

- August 3, 2005: Stipulation of relevant portions of the record. ¶ 2.**
- August 10, 2005: Objections to hearsay portions of the record. ¶ 3.**
- August 24, 2005: Cross-summary judgment papers due. ¶ 4.**
- August 31, 2005 at 10:30 a.m.: Non-evidentiary hearing on the submitted papers. ¶ 5.**

It is ORDERED as follows:

1. Pursuant to the hearing on July 26, 2005 the court shall

treat the Reorganized Debtors' Motion for Court Approval of Stipulation and Order Resolving Cure Claim of Universal Care, Inc. (DE No. 2510), the Liquidating Trust's objection (DE No. 2513), and Universal Care's reply to the Liquidating Trust's objection (DE No. 2510) as cross-motions for summary judgment.

2. The parties shall stipulate to the relevant parts of the record by August 3, 2005.

3. Objections to the hearsay portions of the record are due August 10, 2005.

4. Supplemental papers regarding summary judgment, including affidavits beyond what has already been submitted, are due August 24, 2005.

5. A non-evidentiary hearing on **August 31, 2005 at 10:30 a.m.**, to address the papers submitted, shall be held in Courtroom 24, United States Courthouse, 3rd Street and Constitution Avenue, N.W., Washington, D.C. 20001.
