ORDER TO SUPPLEMENT TWENTIETH OMNIBUS OBJECTION TO CLAIMS

The DCHC Liquidating Trust's Twentieth Omnibus Objection to Claims includes a footnote (B) in Exhibit A to the claim of George Danial Do indicating "(B) Proof of Claim 1632 was originally filed for \$107,190.00 but is included in Omni 19 to request disallowance of \$58,325.00 and allow \$48,865.00." Mr. Do's claims, however, were not addressed by the Nineteenth Omnibus Objection to Claims. In addition, the Trust's Twentieth Omnibus Objection to Claims includes an Exhibit B, listing proofs of claims that allegedly include insufficient documentation, but the proofs of claims themselves are not included as an exhibit to the Omnibus Objection Claims. Without the proofs of claims, I have difficulty ascertaining whether the claims are of a type
