**STIPULATION BETWEEN THE DCHC LIQUIDATING TRUST
AND MANAGED ALTERNATIVE CARE, INC.**

IT IS HEREBY STIPULATED AND AGREED by and between the undersigned, that Managed Alternative Care, Inc.'s Claim No. 135 in the amount of \$3,145,835.20 filed against Doctors Community Healthcare Corporation on April 7, 2003, shall be reduced and allowed as a Class 10 – General Unsecured Claim in the amount of \$2,326,782.89.

It is further agreed that The DCHC Liquidating Trust's 19th Omnibus Objection to Claims Against Non-Debtors (DE 3408) shall be deemed resolved *solely* with respect to Managed Alternative Care, Inc.'s Claim No. 135 in the amount of \$3,145,835.20 filed against Doctors Community Healthcare Corporation on April 7, 2003, subject to the terms of this Stipulation. This Stipulation does not otherwise effect or impact prior Orders of this Court concerning Managed Alternative Care Inc.'s claims other than Claim No. 135, or The DCHC Liquidating Trust's 19th Omnibus Objection to Claims Against Non-Debtors (DE 3408) in any way.
