You may append affidavits and documents in support of your response. **The Court has scheduled an evidentiary hearing, at which witnesses will be permitted to testify, for responses to this omnibus objection on December 17, 2008, at 10:30 a.m.**

IF YOU FAIL TO FILE A TIMELY RESPONSE, THE OMNIBUS OBJECTION MAY BE GRANTED BY THE COURT WITHOUT A HEARING. The Court may grant the omnibus objection without a hearing if the objection filed states inadequate grounds for denial. Parties in interest with questions may contact the undersigned.
